## AGREED CONTRACTUAL RELEASE INVOLVING SCUBA DIVING (READ CAREFULLY BEFORE SIGNING)

I, \_\_\_\_\_ (PRINT NAME), hereby agree that in consideration of my request to participate in scuba diving or other related activities, I certify that I am aware of the dangers involved and/or risks inherent in skin-diving, scuba diving and other related events and activities, and I am aware of the basic safety rules for underwater and surface water activities.

I understand and agree that I shall indemnify, defend, and save the Club, its officers and agents harmless from and against any liability, claim, judgment, demand, or cause of action arising out of my use (or that of the named minor) relating to any occurrence in connection with my participation in Club events and my use (or that of the named minor) of apparatus or equipment which could result in harm or damage to me, my family, heirs or assigns or those of the named minor.

I hereby state that I (or the named minor) have previously completed a certified beginning course of instruction in scuba diving prior to this activity, or that I am a student accompanied by a certified and insured instructor.

I personally assume all risks in connection with scuba diving and I hereby release the Club, any officers and/or agents from any harm, injury or damage which may befall me before, during and/or after diving. I further agree to save and hold harmless said persons and/or entities from any claim by me, my family, estate, heirs or assigns arising out of my participation in the activity known as skin diving, scuba diving, or related activities with the Club.

I state that I do not use or possess or know of anyone participating in Club activities using or possessing a controlled substance such as marijuana, cocaine, amphetamines, and the like.

I further fully appreciate the potential risks which are foreseen or unforeseen by me and those arising from conditions related to hazards of diving activity such as skin diving, scuba diving or other related activities.

I further state that I am 18 years of age or older, or the parent/legal guardian of a Club member under the age of 18, named below, who is legally competent to sign this release and I understand the terms herein are contractual and not a mere recital. I further state that I have signed this document as my own and voluntary act and deed.

I have fully informed myself of the content of this release by reading it before I signed it. I assert that my physical condition or that of the participant minor for whom I sign this release is, to the best of my knowledge, such that I am (or the participant minor is) capable of performing under conditions and situations arising at the time and place of engaging in Club diving activities. I do hereby agree to hold harmless and indemnify the officers or agents of the Club for any loss, expense, damage, injury or harm arising from my participation or entry into the event or events, activity or activities to take place in a Club dive (or the participation or entry of the named minor for whom I sign this release).
